I understand ear protection is required while on the firing line and highly recommended while off the firing line. I shall fully indemnify and hold harmless the BUTTERFIELD GULCH GANG their officers, range officers, members and land owners from any and all claims, demands, causes of action, damages, losses and expenses (including attorney's fees) of whatever nature, character, or description that any person or entity has or may have arising from or related to any incident resulting from any negligent act, omission, misconduct, or fault of THE BUTTERFIELD GULCH GANG, its officers, range officers, agents, members, or the range owners.
